3a. ESCP Bulletin in preparation. Will be published in August. Addition band codes of the national PAs.

3b. *Italy*: Italian Frill, tail position is in conformity with the standard image.

*Belgium*: Standard images are coming (as ever).

*Gr, Britain*: Standard texts for Genuine-, Exhibition- and Show Homer are agreed by GB - NPA. Will be mailed to the ESCP members.

For these breeds in the column SDA in the ELFP ESKT can be changed into GB fat. Other breeds will follow.

*Germany*: Image of the Bohemian Pigeon goes to the German Standard Committee.

3c. Information:

*Austria*: Pommerian Cropper recognized in black magpie.

Colour *Ecrú* accepted. Description in the ESCP Bulletin 2018

*Poland*: For following breeds the standards are in conformity with the EESP standard format (ESCP Regulation):

Old Polish Wattle Pigeon 0120

Kalisz white Tumbler 1062

Polish Moortumbler 1026

Polish Colourbreast Tumbler to be entered in Herning for identification.

Band size for muffed 10 mm

Starwitz Cropper: request for Change SDA and discussion about beak colour.

In ELFP the SDA is Germany. Before 1945 Silesia was part of Germany, is now Poland. ESCP is not authorized to change SDA.

Will be discussed with PL delegation.

For genetic mealy beak colour is dark.
