

Minutes of the ESCP session in Treviso-I, September 27 2014

ITEM 1. Welcome and presense

Chairman Jean Louis Frindel (JLF) welcomes ESCP members August Heftberger-A (AH), Reiner Wolf-D (RW), Claude Schneider-CH (CS), István Rohringer H (IR) and Hans Schipper NL (HS), Secretary

EE-judge badge.

This topic is discussed outside the business of the ESCP session.

The following criteria are laid down:

Demonstrable

- (a) - two participations of an *international* judge training session plus
 - one judging at an EE Show or European Show for Specific Pigeon breeds (ESSP).
- b) - one participation in a previously to the EESP announced *National* judge training session with EE item plus
 - judging at two European shows (EE Show or ESSP) or International Show(s) for Specific Pigeon breeds in a year where an EE European Show takes place.

The rules for the award of the PR badge is changed as above.

For European shows (EE Show and ESSP) badge decorated judges are recommended.

ITEM 2. Minutes of meeting

Minutes of meeting in Sarajevo 2014: approved. Confirmation at ESCP session and EESP meeting 2015.

ITEM 3. Open files to the European standard (+ ELFP)

3a) Problems standards UK.

Last date for response of suggestions to resolve comments on UK standards was set at September 1st 2014, according to the resolution of ESCP and ESFP sessions in Sarajevo 2014.

At that date no document is arrived from NPA UK.

Reason for decision in accordance with the meetings in Sarajevo. Resolutions as in attached table.

At September 15th last email has been sent to Mr. Colin Ronald, Secretary of NPA-UK.

In that mail textual adjustments are split up in:

- Supplement (Syrian Swift, Dragoon)
- Correction (Jacobin and Nun UK)
- Realistic formulation (Turbit and Oriental Frill)
- Animal welfare (Carrier and Norwich Pouter) in accordance with the Constitution of the NPA-UK, section c4!

In the email of September 15th ESCP informed the NPA Board of Officials if UK standard texts and images will not be changed as proposed by the ESCP, ESCP will set up adjusted European standards for the respective breeds, based on UK standards. For those standards the ESCP becomes SDA.

The EE list of fancy pigeons (ELFP) will be changed in accordance at October 1st.

The standard of Modena UK will be confirmed at the ESSP for Modena's in Illkirch/ F at November 15th. NPA UK, NMC-UK, and breeders will be invited for a meeting about. This shall be directed by the ESCP.

3b) Images UK standards

JLF sent corrections or drafts of some default images to NPA UK.

The limit date was extended up to the 21-09-2014. No response.

3 c) Other projects (JLF)

- *FelégyhazerTumbler*. Two breeds exist named Kiskunfélegyházer Tumbler: the one crested the other plain headed (Simafejü). The standards show significant differences.
The name has led to confusion. IR has dealt with this. ELFP will be corrected.
- *Texan Pioneer*. New image. Established in Sarajevo. Will be completed.
- CS: In CH a few standards for Swiss pigeons are changed and already published in the F standard. Supplements. SDA agrees with the changes.
- *French Pouter*. Comes new standard image
- *as well as a few pictures in German standard*

Standard changes will be published the ESCP Bulletin 2015.

ESCP Chairman closes the meeting at 18:00.
